4. 1st Vice President's Report: Effie Pressley

**League Affiliate Liaison-** Carl- nothing at this time unless Vince has something different. He spoke with Mike Serra and Lori Buckelew about the disruption – they are aware of it and will work so there is sufficient times in between sessions so this doesn't happen again.

**Legislative**: Chris Assenheimer-Lame duck session is over, there are over 150 bills for him to act before next Tuesday. Once that is passed, he will reach out to Carl so they can summarize the bills

2 bills – S8062 refunds excess taxes that were paid by the tax appeal as credit A2877- risk of Blight Received last night- there are 312 bills that go over taxes or assessments. S259 converts Senior Freeze credit applied directly to taxes- multiple bills out just on this idea. S51 Increases gross income tax deduction for homestead property taxes paid up to \$ 25,000.00. ACR42 freezes property tax of homeowners 65 years or older. A1646- homestead school property tax reimbursement for school taxes- ages 65 or older. A1540 municipal volunteer act. A1649 increases income level for the homestead reimbursement. A1327 revises established base year after moving for homestead. A1481, S163 excludes veteran disability compensation from income qualification under the homestead reimbursement plan. A1647 increases annual income limit for homestead rebate. A391 clarifies notice required if interest changes. A1650 requires reimbursement for property taxes of exempt veterans - multiple bills on this idea

**Atlantic County-** Jessica Snyder- She missed the December holiday meeting because she had COVID, unsure if they are having a virtual meeting in March

**Bergen County-** DeMaio, Jody- Probably be meeting virtual in March. No Holiday Party due to low interest and attendance. Asked if we could use the TCTA's zoom. Carl just asked that she contact Vince

**Burlington County-** Julia Edmondson- Mary P has no report – no contact from the president in a year and a half. Carl is still looking to make contact with the County Presidents to make sure they are coming to the meetings, having their own meetings and getting ready for the audit

**Camden/Cumberland/Gloucester/Salem-** Tracey Gregoire- Had a meeting on Monday the  $10^{th}$  – the Officer's were sworn in. Will meet with the board members on the  $16^{th}$  and they will be setting up the meetings. First meeting in March which will probably be virtual.

They started doing a scholarship mini conference many years ago which she has been chair of for a few years and they will be doing that on the boarder of Warren and Sussex County in April. She is retiring as of April 1<sup>st</sup>- she will still continue the conference.

- **8. President's Report** Carl- Auditor's contract- Vince will look into prices of other auditors and bring back to the next meeting. Going forward if you want contracts, he would be happy to forward them- no one reached out to him prior to the meeting for the contracts- he would have gladly sent it out. Reiterated he and the vice presidents will be contacting the County Presidents.
- **9. Executive Director's Report** Vince- thank you to the associations for their best wishes and condolences on the loss of Marilyn. It happened fast, exactly 16 days from the date of diagnoses to death. Appreciate all those that came to the wake and especially the funeral mass to help celebrate her life with us. Legislature opened 220 sessions-he anticipates that there will be anywhere from between 3000 to 6000 bills introduced with probably 150 of them being passes. Things have been quiet no labor issues right now. Working with the Hard Rock to set up registration.
- **10. Legal Counsel's Report** Keith- a lot of bills came out last minute- not sure what the Governor is going to sign. Vacant property registration was substantially amended and may make a change to become a lien. The Governor did sign a bill extending Executive Order 190. He will issue a TCTA alert and a more formal guidance later. He will continue to give guidance for everyone. On the amicus brief on bankruptcy that was filed- the opposing attorney passed away in December so they are waiting to see if there is a replacement.
- **11. Membership Services-** Went live January 1<sup>st</sup>, 1137 emails went out, 41% opened- will be mailing another one out next week. 19 members paid so far.
- 12. Rutgers-Center for Government Services Report- Pam-Happy New Year, Vince- on behalf of Rutgers, we extend our deepest sympathy on Marilyn passing and our prayers for your health and healing. Rutgers is still working online and all classes are virtual. Student seem to prefer the online classes and there has been no discernable impact on passing the class-that's a positive thing. Last semester they had about 115 students. The schedules are online with Rutgers and our website. There are no more mailings. The biggest problem with the classes is that the students are unhappy receiving an online manual for the classes, prices were reduced because they are no longer printing and shipping. She did meet online with Marge for the Exam- she lets them know what might not be working well as far as understanding the curriculum or misunderstandings in what is being taught in the class and the exam.
- **13. Division of Local Government Services:** Marge- The December exams don't have their grades yet due to COVID breakout at work about 50 took the exam, 22 of them got their provisional licenses and four of them have unrestricted licenses. A little more than half passed kudos to the instructors. It is intended that the Homesteads go on the May quarter. If you are changing vendors, please let Marge know. Files can't be sent to more than one vendor. S4081- should

be getting a local finance notice out- lots of layers of government to go through, it does extend EO 190 but also includes sewer. Marge will be able to attend the March meeting.

**16. New Business**: Linda- anyone having a problem with having names show up on the internet. Carl stated that Ocean County is doing it based on a form, the name will change to the address. Vince will start to lay the ground work on the website so we can do it.
